Year in Review

From the addition of new Interlocal Members and staff, to the receipt of large grant awards to fund several key projects and initiatives, 2024 was a year of growth and development for the Jordan River Commission.

We have been pleased to welcome Utah Lake Authority and Larry H. Miller Company to our Governing Board this year. Utah Lake Authority is a new state agency that replaced the Utah Lake Commission, and we are grateful for the unanimous support of their governing board to become a full Interlocal Member.

Larry H. Miller Company revealed their vision for the Power District in early 2024, which will lead to the redevelopment of the Rocky Mountain Power Gadsby Power Plant near the Jordan River and North Temple in Salt Lake City. Seeing the important place of the Jordan River in their vision, we are pleased to have them recently join the Commission as a new partner and stakeholder.

The Commission added a new, full time Administrative, Grant & Research Specialist position, and filled our Event & Volunteer Manager, and Restoration & Vegetation Coordinator position vacancies. We expanded internships and seasonal staff for the Get to the River Festival, and volunteer and outreach programs. Each member of our staff shares a passion and commitment to the Commission work and partnerships.

Several large federal grants, more than \$6 million in total, were awarded to the Commission and our partners for several key projects: major riparian and flood plain restoration, expanded community connections, and creating a new Jordan River Watershed mobile app that will expand watershed and recreation education and digital map resources. Ongoing legislative appropriations, Utah Trails Network active transportation funds, and Division of Outdoor Recreation Grants continue to fund riparian restoration, trail development and maintenance, and a variety of outdoor recreation improvements to the Jordan River Trail, Parkway and Water Trail.

In January, the Utah Watersheds Council fully certified the Jordan River Commission as the Jordan River Watershed Council, under the authority of the Watershed Councils Act passed by the Utah Legislature in 2020. Members of the Governing Board will now also serve as Members and Advisors of the Watershed Council. This brings greater focus and new partners to our watershed wide approach to water policy issues, from water conservation, to water quality, to the connectivity with Utah Lake and Great Salt Lake ecological systems.

We are grateful for all those supporting the mission and work of the Jordan River Commission in so many ways, and the great momentum and partnerships that make it all possible.

Jordan River Watershed Council

On January 18, 2024, the Jordan River Commission was certified as the Jordan River Watershed Council, after previously being conditionally certified in April 2023. As a new watershed council, we worked together to identify some specific objectives and timelines to make progress based upon the Blueprint Jordan River Refresh, which provided plenty of priority tasks and actions for us to work on as a group.

We had a great year getting started in this new configuration. Salt Lake County had a watershed council for more than a decade with a focus on water quality in the county. The Utah Watershed Council Act expanded participation by adding more stakeholders and water interests. There were other grassroots groups working on watershed issues, but this year the entire watershed — ridge to ridge across Utah, Salt Lake and Davis counties — came under one umbrella.

We have worked together to improve our collective understanding of the watershed, including sharing data and knowledge of water distribution and canals, water quality and development, conservation and reuse, recreation access and public safety. We are looking forward to sharing knowledge across disciplines in our regular meetings and as part of future workshops on specific topics.

Local watershed councils encourage and facilitate discussion and collaboration or water-related issues and concerns among the stakeholders within the watershed. As feasible, the watershed council will facilitate communication and coordination among the following interests:

- Agriculture
- Industry
- Utah tribal nations
- Public water suppliers
- Water planning and research institutions
- Water quality
- Fish and wildlife
- Water dependent habitat and environments
- Watershed management
- Mutual irrigation companies
- Local sponsors of reclamation projects



Each local watershed council designates a representative to serve on the <u>Utah Watersheds</u> <u>Council</u>, which is a forum for discussion of water where issues of concern can be brought to the attention of the Legislature and Governor.







2024 Highlights

Notable Development Projects along Jordan River

In 2024, significant development projects emerged along Utah's Jordan River, notably **The Power District** in Salt Lake City, **The Point** in Draper, and the **Wander Development** in Saratoga Springs. The Power District represents a historic investment in Salt Lake City's westside and will revitalize the Jordan River and Fairpark neighborhood. The Point commenced its first phase of construction in December, and includes the 1.4 mile River to Range trail that will connect the Jordan River Parkway to the west with the foothills to the east. The trail will serve as a vital component of the regional trail network, promoting outdoor recreation and connectivity within the community. The eastern boundary of Wander Development in Saratoga Springs is oriented around the Jordan River and incorporates a 50 foot riparian buffer as well as a 30 acre linear park along the river. Collectively, these projects are transforming the Jordan River corridor, promoting economic growth, community engagement, and enhanced recreational opportunities for Utah residents.

America the Beautiful Challenge Grant Project Kickoff

On August 30th, The Jordan River Commission and its partners convened at the Big Bend Nature Park and Preserve in West Jordan to announce a significant restoration initiative funded by the America the Beautiful Challenge Grant. This grant, administered by the National Fish and Wildlife Foundation, allocated approximately \$5 million to support comprehensive restoration efforts along the Jordan River corridor.

The funded projects encompass several key initiatives:

- **Big Bend Nature Park and Preserve Restoration:** Led by the City of West Jordan, this project widens the river's floodplain, creates a secondary channel, and adds thousands of native plants to enhance habitat and improve water quality.
- Invasive Species Management and Native Plant Restoration: Coordinated by the Utah Division of Forestry, Fire & State Lands, this effort focuses on removing invasive species the river and reestablish native vegetation.
- **Gillmor Sanctuary Enhancement**: Managed by Audubon Rockies, this project aims to restore wetland and upland habitats by controlling invasives and reintroducing native plants, thereby improving conditions for birds and wildlife.
- Community Engagement and Science Initiatives: The Jordan River Commission will lead conservation programs, including community science and volunteer stewardship, to foster a sense of ownership and support for the river's health.

This project represents the largest coordinated riparian restoration effort on the Jordan River, and aims to revitalize the watershed and enhance its ecological health for future generations.

The Commission Staff and Technical Advisory Committee offer support, input and expertise on many of these projects. Restoration

Jordan River Restoration Project with Utah Conservation Corps

Utah Conservation Corps brush cut Phragmites, controlled Russian olive and tamarisk, pulled puncturevine, removed thistles, sowed seed, planted trees along the Jordan River and repaired fencing to project trees.

- 48.42 acres of habitat improved
- 41.55 acres of invasive species removed
- 1,088 pounds of puncturevine removed
- 6.12 acres were planted with seeds and trees

Education and Outreach

As we expand and support recreation enhancements along the Jordan River, it is important that we are connecting new users to these resources and educating them on how to utilize the trail and the river. Recreation connects people to a place and creates a desire to take care of it and invest in it. It also gives us a chance to educate on the other issues affecting the river. This year we expanded our recreation programming by adding bike and walking activities with the public.

The Jordan River Commission partners with many fantastic organizations to educate the public about the Jordan River and the watershed. We teach about the ecological systems of the river and the impact human activity has on it and what we can do to restore the natural systems of the watershed. This year we also hosted three free film screenings.



#LoveYourWatershed Initiative

The Commission has two monthly activities to educate and activate the public around our stormwater system. On #FirstFriday, we post a challenge on social media for the public to complete on their own. On #SecondSaturdays we host a cleanup along a major roadway that crosses the Jordan River. We partner with local cities and UDOT for these cleanups. We also make cleanup kits and share those at community events.
